Battlefield forward Tim Horn reached over his head from behind and swatted the ball out of bounds, forcing SJ to eat up another 10 seconds of clock time before Warren sank a 3-pointer with 20.3 seconds left. James Robinson proved to be a thorn in the Stonewall side again late in a game he finished off a series of bounces with a lay-up that Warren had to answer by storming the length of the court with some hoop and harm of his own. He converted the free throw to cut the score to 50-49, now with 6.5 seconds on the board.

Battlefield won 50-49 and was headed back to the Cedar Run District championship.

On Feb. 20, however, the scene was less cheerful as Battlefield went down to Fauquier and its star player, Jerrelle Benimon. The Falcons prevailed, 57-50, in overtime in the Cedar Run District boys basketball tournament championship, held at FHS.

Battlefield (16-8) did nearly everything in their power to win. The Bobcats bolted from a 22-22 halftime tie with a dynamic third quarter. Back-to-back 3-pointers by senior guard Jahmal Jones, followed by two Jones' free throws, gave the Battlefield a 35-27 lead late in the third.

That's when FHS guard Joey Geary hit a shockingly long 3-pointer from way behind the top of the key that Ford called the biggest play of the game.

Battlefield rebuilt its lead to eight at 39-31 on a drive by

Robinson to open the fourth quarter, before Fauquier stepped up its play.

A Benimon coast-to-coast layup, two Josh Simons free throws, a Geary 15-footer, and then a layup by Connor McCartin cut the Battlefield lead to 41-39. Falcon Alex Ritter then nailed two clutch free throws to tie it at 41-41 with 2:58 left.


Two Benimon free throws

with 49 seconds gave the Falcons a 46-43 lead, before Robinson (15 points) scored on a driving shot and was fouled by McCartin. Robinson's free throw tied it at 46-46 with 37 seconds left.

Fauquier dominated overtime from the get-go. Geary fed McCartin for a quick layup, then Benimon scored five more points for a 53-48 lead, and soon the Falcons were hoisting the trophy.
